**Notification of upcoming Highway Improvement Works – North Peckham Healthy Streets  
Experimental modal filter on St Georges Way**

As part of proposals to improve walking and cycling facilities and make the North Peckham area safer for all road users, we recently consulted on various measures including introduction of a modal filter on St Georges Way under an experimental traffic order. The measures have now been approved for implementation and the experimental measures will be installed for a maximum of 18 months, and within that time, the council will carry out several reviews and will consider people's views to decide whether to make the trial permanent, amend it or to remove these measures.

Anyone wishing to object to the making of the permanent order or make any representation regarding the scheme would have until 16 November 2022 to do so and may send a statement to [traffic.orders@southwark.gov.uk](mailto:traffic.orders@southwark.gov.uk) or to Traffic Order consultations, Highways, Southwark Council, Environment and leisure, P. O. Box 65429, London SE1P 5LX quoting reference *TMO2122-EXP16\_ST Georges Way*. Please note that if you wish to object to the scheme, you must state the grounds on which your objection is made.

The work measures proposed and anticipated duration are listed below:

**The above proposed start date may be subject to change due to unforeseen circumstances.**

These works will be implemented between 08:00 hours and 17:00 hours (Monday to Saturday, weather permitting). Please note that footway areas will be maintained for use outside of these hours.

We are aware that these works may cause some disruptions to residents, local businesses and visitors, however, we will endeavour to keep this to a minimum. The duration of works specified above is only indicative, we will endeavour to complete the works in the minimum time possible. It is possible, however, that the works will take longer than expected if we encounter any unforeseen difficulties, for example bad weather.

For these works to be carried out in a safe working manner appropriate traffic management under signal control is to be used, the carriageway must be kept clear from parked vehicles at the locations highlighted above. We will use 'No Waiting' cones and signs to indicate the extent of any parking restrictions. If a vehicle is obstructing the works, the Council may relocate the vehicle. If you think your vehicle may have been towed or repositioned, try TRACE on 0300 077 0100 or go to <https://trace.london/> to find out. Clearly, we would prefer not to do this so please try and observe the cones and signs accordingly.
