Notice is hereby given, in accordance with section 22 (8) of the Telecommunications Act 1984 ("the Act"), by the Secretary of State that he proposes to designate a standard

under section 22 (6) of the Act.

The effect of this designation will be to withdraw the approval of British Standard 6317: 1982 given under section 16 of the British Telecommunications Act 1981 and in its place to designate the same standard, as amended by Amendments 1, 2 and 3, as the standard, as amended by Amendments 1, 2 and 3, as the standard with which Simple Telephones must conform if they are to be approved under section 22 (1) of the Act. The Designation will apply for the purposes of approval of Simple Telephones for connection to branch telecommunications systems. This notification is addressed to persons who run such systems.

The Secretary of State proposes to specify the following

conditions in the designation:

Terminal apparatus shall only be regarded as conforming to the standard hereby desinated if the following conditions are complied with as regards that apparatus:

- (i) in the case of terminal apparatus which is required, under an Order made or having effect as if made under section 28 of the Act, to be marked to show whether or not it is apparatus approved under section 22 (1) of the Act, it conforms to a level of safety consistent with the United Kingdom's obligation under the European Communities' Council No. 73/23/EEC on the harmonisation of the laws of Member EEC on the harmonisation of the laws of Member States relating to electrical equipment designed for use within certain voltage limits;
- (iii) it is not used as extension apparatus to a payphone.

The Director General of Telecommunications has been asked by the Secretary of State to advise him on the terms of this designation.
