- 2. Ullswater House has not been included as it is not self contained accommodation. Residents in Ullswater House are on the housing register and are included in the figures set out in 6 below. In respect of the replacement of the 47 homes at Ullswater House, we will not be replacing like with like as they are not self contained. If we replace them in proportion to the current tenanted need on the estate it would mean that we need 218 replacement council homes as follows:
