Public Path Diversion Order 1980*

Notice is hereby given that on 17th November 1980, the Stratford-on-Avon District Council confirmed the above named Order as an unopposed Order.

The effect of the Order as confirmed is to divert AL. 58 at Turner Engineering Limited, south westwards for approximately 96.5 metres to a line commencing at the first point mentioned above in a west south-westerly direction for approximately 28.5 metres, then westerly for approximately 22.5 metres, then southerly for approximately 65 metres for a total distance of approximately 116 metres.

The Order becomes operative as from the date on which the Stratford-on-Avon District Council certify that the alternative footpath has been created to their reasonable satisfaction, but if any person aggrieved by the Order desires to question the validity thereof, of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the grounds that any requirement of that Act or any regulations made thereunder has not been complied with in relation to the confirmation of the Order, he may make application for the purpose to the High Court within 6 weeks from 21st November 1980, under section 244 of the said Act.

#### EAST SUSSEX COUNTY COUNCIL

*The County of East Sussex (Bexhill No. 26a) Public Path  
Diversion Order 1980*

Notice is hereby given that the above-named Order (herein after referred to as "the Order") made on December 1980 is about to be submitted to the Secretary of State for confirmation or to be confirmed without modification by East Sussex County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public footpath known as Bexhill No. 26a which runs from Peartree Lane to Broadoak Lane from a point at the south-eastern corner of Parcel No. 852 as shown on the 1930 edition of the Ordnance Survey eastwards to a point near Oldebarne Farm. The new path will run from the same point north-eastwards and eastwards for a distance of 109 metres and then proceed south-eastwards for a distance of 17 metres to a point in Broadoak Lane near Oldebarne Farm.

Existing and proposed routes are described in Parts 1 and 2 of the Schedule to the above Order and shown on the map attached to the Order.

Copies of the Order and map have been deposited at the offices of the Rother District Council, Town Hall, Bexhill-on-Sea, and at the offices of the County Records Officer, Pelham House, St. Andrews Lane, Lewes, and may be inspected, free of charge, during normal office hours.

Any representations or objections in respect of the Order may be sent in writing to the County Secretary of East Sussex County Council, Pelham House, St. Andrews Lane, Lewes BN17 1UN, not later than 22nd December 1980 and should state the grounds on which they are made.

If no representations or objections are duly made, or if any so made are withdrawn, East Sussex County Council

may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations or objections which have been duly made and not withdrawn will be submitted to the Secretary of State with the Order.
