A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Technical Services Department, Mendip District Council, Council Offices, North Parade, Frome, during normal office hours.

The Order becomes operative as from the date on which the Somerset County Council certify that the new path has been created to their reasonable satisfaction, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 244 of the Town and Country Planning Act 1971, within six weeks from 9th May 1975, make application for the purpose to the High Court.

##### THE SCHEDULE above referred to

##### *The Eastern Extension*

The boundary runs eastward from the northern boundary of the Nursing Home in Grove Park, along the railway embankment to the rear of No. 91 Grove Park. It runs southward to the rear of No. 83 Grove Park and then eastward along the rear of Nos. 27-35 (consec.) Grove Park. It then travels southward, along the eastern boundary of No. 27 Grove Park, to the southern side of Grove Park. It then runs west, to the boundary of No. 25A Grove Park and continues south-westward along the railway embankment to the south side of Copleston Passage and travels westward along Copleston Passage to meet the south-eastern boundary of the original Conservation Area at the rear of No. 31 Grove Hill Road.

##### *The Western Extension*

The boundary runs south along the western side of Grove Lane to the boundary of No. 98 Grove Lane. It then encircles Nos. 1-53 (consec.) Champion Grove and continues south along Grove Lane to the southern side of Grove Hill Road and then eastward to the south-western boundary of the original Conservation Area.

##### *Torquay Harbour Conservation Area*

The area surrounding Torquay Harbour with its boundary running in an irregular line northwards from a point between the Imperial Hotel and Peaked Tor Cove to the junction of Braddons Hill Road East with Babbacombe Road. The boundary then runs along Braddons Hill Road East to a point roughly 150 yards north-west of its junction with Braddons Hill Road West. From here it runs roughly east-west across the Fleet Valley to Warren Road whence it runs southwards and then westwards to rejoin the sea-front immediately to the west of Princess Pier.
