1. Introduction

1.1. The Southern Entrance Project: Overview

Following completion of the Revitalise Burgess Park project in 2012, Southwark Council is looking to improve other areas of the park which have not had any changes made to them.

During the first two phases of the park's revitalisation, no improvements were made to the south western area of the park including Rust Square, the nature area and adjacent grassland. Southwark Council now plan to landscape and improve this area of the park and we are calling this the Southern Entrance Project.

The first public consultation on the Southern Entrance Project took place in December 2014. Respondents to the survey were asked to choose between two concept designs for each of four key areas that make up the Southern Entrance Project site. These areas are Rust Square, the open space adjoining Rust Square, the central open space and the nature area. The results of the first consultation helped shaped the design in the following way:

- The project was popular, with only a very small percentage of respondents disliking the two concept designs.
- Of the two design concepts presented, concept two was more popular, so we have based the new design on concept two.
- More respondents to the survey mentioned that they were in favour of integrating the Rust Square with the
 rest of the park rather than keeping it separate. However at the public meeting the majority wanted Rust
 Square to be separate.
- Nobody objected to having a play area but some thought it was not the correct location, so we have relocated it further into the park so that properties do not overlook it.
- Opinion on the water feature/fountain was divided, with slightly more people preferring not to have a water feature/fountain, so we have not included a water feature in the new design.
- Some people preferred winding pathways as they felt it would make cyclists travel more slowly. Others
 preferred straight pathways as they felt it would be better for safety, with clear sightlines of who is coming.
 Therefore pathways in the new design are a mixture of both straight and meandering pathways.
- Slightly more respondents mentioned that they think cyclists and pedestrians should share paths, but there was also support for separate paths. Generally people did not want additional paths, so in the new design we have kept pathways to a minimum.
- From experience, the best way to make pathways safe for both cyclists and pedestrians is to make them wide enough so they can pass by at a distance, so we've suggested 5m wide pathways.
- There is concern from nearby residents about antisocial behaviour. Attracting well-behaved visitors to an area with facilities such as play equipment and an outdoor gym is likely to encourage social behaviour, in turn discouraging antisocial behaviour.
- Results clearly show support for a new large pond. There was also support for removing New Church Road from within the park, so these elements are being retained within the design.

- More than 80% of respondents were opposed to the idea of the Wells Way underpass being reserved for cyclists' use only, so it will be kept for use by everyone.
- There was support for a new crossing on Wells Way and for a new bandstand or performance space, but the support was not overwhelming.
- Although there was some support for a new BBQ area, many people objected to it, and comments reflect that
 the location is an important factor. As we are aware of demand for more places to hold BBQs we have
 suggested a new location at a good distance from nearby properties.

Based on the analysis of the responses to the first public consultation, the plans were updated and formed the basis for the second public consultation. The second public consultation was on one design proposal and ran from May to June 2015. The updated design proposal included an improved nature area and new large pond, play equipment, an outdoor gym and a barbeque area. Outcomes of the second public consultation are presented in this report.

1.2. Second Public Consultation: Objectives

The key objectives of the second public consultation were:

Key objectives:

- Presentation of an updated concept design for the Southern Entrance Project to the public
- Informing the public of how the results of the previous public consultation have influenced the design
- Encouraging a broad range of park users to give feedback on the updated concept design
- Insight into what type of equipment people would like in the play area and outdoor gym.

2. Executive Summary

This summary highlights some key findings from the second public consultation for the Southern Entrance Project at Burgess Park. They are drawn from the survey and from the discussions that took place during the stakeholder meeting and public event in May.

Overall satisfaction with the plans

When asked about their overall satisfaction with the plans presented, a majority of respondents were positive (76%). Respondents were also generally well informed about the plans prior to completing the survey – only 5% of respondents said they had not seen them.

Play area

"Swinging" was the most popular play option (43%). This was followed closely by "Climbing" (43%) and "Sliding" (38%). **Twenty one respondents (6%)** suggested a **water play feature** with a paddling pool being the most popular suggestion in the "other" category.

There was some concern that the proposed play area did not address the demands of certain age groups, with 27 respondents (6%) leaving 'further comments' at the end of the survey stating they felt younger children were not catered for.

Location of play area and barbecue area

It was acknowledged that the barbecue area can be a positive social hub for the local community. The play area was also considered in a positive light by many.

However, some local residents were concerned about the **proximity of these areas to residential properties** – 24 respondents (6%) mentioned this when commenting on why they liked *some* of the plans. Residents were concerned with the potential for disruption and antisocial behaviour arising from the use of these areas.

Nature area and large pond

The majority of respondents were positive about proposals to increase biodiversity (69%), having a bigger nature area (65%) and a large pond (59%).

Some respondents were against the large pond - 6 of respondents (1%) disliked the idea. The most common reason was because it was felt another water body was not required in addition to the existing lake.

Cycle pathways

Updates to cycle routes remained a contentious issue; drawing some impassioned views regarding the park's cycling infrastructure. Of those who stated that they *disliked* the plans, 4 respondents stated that it was due to the proposals regarding the cycle paths. However, 13 respondents who liked the *overall* plans for the park did so because of the updates to the cycle paths and its accommodation of pedestrians.

3. Consultation Programme

The second public consultation for the Southern Entrance Project was both an engagement exercise and a means of collecting park users' opinions.

Quantitative data was captured using a survey that was available online and in print. Several questions within the survey incorporated free text boxes - allowing for extensive qualitative data capture. The survey was bolstered by a facilitated stakeholder meeting and a public event.

The plans exhibited to the public were based on the outcome of the first public consultation. Exhibitions of the plans were displayed at the Old Library on Wells Way, Burgess Park Community Sports Centre and Burgess Park Tennis Centre. There was an additional exhibition at Chumleigh Gardens at weekends and during school half term.

3.1 Southern Entrance Project Survey

3.1.1. Southern Entrance Project Survey

As part of the second public consultation, a survey was available online and in print. Respondents were asked for their thoughts on proposals for the nature area and what they would like to see prioritised within the play area and outdoor gym. A copy of the survey is in **Appendix D**.

The survey was launched at the Southern Entrance Project Stakeholder Meeting on 18 May. An online version of the survey was publicised on the Southwark Council website Consultation Hub, through the project's mailing list, a leaflet distributed to 2,300 households around Burgess Park and handed out in the park and posters in the park noticeboards and around the project site. Hard copies of the survey were handed out by Park Ambassadors at the Chumleigh Gardens exhibition. Social media in the form of Southwark Council's twitter feed was used to promote the survey, the public event and the exhibitions.

In total, 421 people completed the survey. Of this number, 123 did so online while 298 respondents completed hard copies of the survey.

3.2 Exhibitions

Exhibitions with the updated Southern Entrance Project concept design were displayed in four different locations in May and June.

These exhibitions were held at the following locations:

- Old Library (also known as the Wells Way Pop Up) on Wells Way
- Burgess Park Community Sports Centre
- Burgess Park Tennis Centre
- Chumleigh Gardens (at weekends and during school half term only)

3.3 Stakeholder Meeting

Stakeholders were invited to view and discuss the updated plans for the Southern Entrance Project. The meeting on 18 May was attended by 12 stakeholders.

At the meeting, council officers provided a summary of the feedback from the first public consultation, followed by a structured discussion during which thoughts about the updated plans were received. The survey was made available for attendees to fill in individually. These were collected at the end of the session.

Below is a summary of the themes from the discussion.

Play area

There was some concern about the location of the play area. It was suggested that at present the location is too close to houses that back onto the park and it was suggested that the play area be moved further from residential properties. It was noted that there have been problems with anti-social behaviour in the past, with people climbing over walls and noisy gatherings.

One stakeholder suggested play should be widened out across the park with links from one play area to another to encourage movement though the park. The play trails in the Burgess Park Master Plan were mentioned by Southwark Council officers to address this idea. It was asked if more play is available on the Elmington Estate.

Rust Square

Stakeholders were interested to know what is going to be done to make Rust Square more attractive. It was mentioned that there will be wild flower planting and seating. A question about more lighting was also asked.

Barbeque area

It was mentioned that the proposed BBQ area is only 100 yards from housing. It was suggested it would be fair to place the BBQ area equidistant from homes around the park to reduce disturbance to residents.

Council officers agreed that there is high demand for barbequing at Burgess Park and commented that a focussed space make this easier to manage. The cut off time for barbeques was questioned; 9pm is the cut off time for cooking. The council admitted there have been problems in the past and this continues to be a challenge to manage but plans are in place to tackle any disturbances.

Positively, it was noted that the BBQ area creates a great atmosphere, with parties into the night but these are hard to stop. It was suggested that situating the BBQ area next to the old lime kiln was a great space and it is currently under used.

Footpaths and cycle ways

There was some discussion around creating new pathways which reflect the natural 'desire lines' people already make themselves, for example close to the BMX track and by Addington Square. It was mentioned that the pathways around the tennis centre do not work.

It was asked if there is a case for having different coloured paths for the shared cycleway. It was thought that this may be helpful in indicating to cyclists where they need to go slow and it was thought this might encourage slower cycling. As well as discussion about coloured pathways, widening of paths was also discussed.

Outdoor gym

The discussion on the outdoor gym centred on the high use of current gym equipment and whether the equipment will be dotted around the park or all in one place. It was noted that having all the equipment in one place can be intimidating for some users, using the existing outdoor gym near Albany Road as an example as this is commonly dominated by groups of men. It was suggested a better option might be to have small groups of equipment spread across the park, as this would also encourage different groups of people to use the equipment.

Entrances

There was a general comment that the plans for planting are attractive and it was asked if there are any plans for ornamental planting at the entrance to Rust Square as a "welcome to Burgess Park". Council officers confirmed there would be increased planting at key entrances and planting to encourage wildlife – such as wild flowers and spring meadows, but limited ornamental planting as this is expensive to maintain.

General comments

There was a comment about plans taking into consideration how people naturally use spaces in the park – i.e. some people don't want to sit in the middle of the park to picnic, they want to sit by the edges or near the trees for shelter. Also, it was mentioned that there needs to be thought about where people are coming from, and how they get to the BBQ areas.

Also it was noted that there seems to be a lot of activity in places near homes and there is wider space across the park that could be used.

There were questions raised about what will happen to the scrap yard and garage, the GLC gate posts and the old pub (now a private residential building). It was also asked if a band stand could be erected in the park.

3.4 Public event

A public event where park users could come and see the plans and take part in activities with their families was held outdoors near the tennis courts on the 31 May. The event was held during half term as the park is busier during school holidays.


As there were visitors throughout the day, no structured discussion took place – instead, conversations were held with local residents and stakeholders who attended the event. Park Ambassadors were handing out leaflets to promote the project. Some people completed questionnaires on the day and others took away details for completing the survey online.

4. Southern Entrance Project Survey

4.1. Overall Plans

4.1.1. Views on the plans for the south western section of Burgess Park

The majority of respondents to the survey either liked all or some of the plans proposed (76%). Most respondents viewed the plans prior to completing the survey – only 5% said they had not seen them.

4.1.2 Free text responses

If respondents *liked* the plans, *liked some* of the plans or *disliked* the plans, they were encouraged to comment on why they felt this way via a free text box. In total, the question drew 255 comments.

For the purposes of analysis, comments were grouped into themes and were tallied based on the frequency they were mentioned. The number of respondents for each theme may not correspond with the total number of comments received for each response. This is because one comment may have flagged several issues.

Comments grouped within 'other' are those which do not fit into any general theme or were not frequent enough to warrant their own theme

Due to the high number of comments received from respondents who 'liked' and 'liked some' of the plans, themes were based on similar comments/points raised by at least 8 respondents. A full list of comments including 'other' comments can be found in **Appendix B**.



4.2. Play Area

4.2.1 What respondents would like to do in the play area



Of the 371 respondents who answered this question, "Swinging" (43%) proved to be the most popular followed by "Climbing" (40%) and "Sliding" (38%). There was little difference in popularity between the preferred options. This suggests that respondents who selected any of the options from the list were generally content with any or all of these options.

Run (28%), Dangle (28%) and Rock (23%) elicited the least number of responses.

Two fifths (41%) of respondents completing the survey did not feel strongly enough about this area to comment on the types of play equipment. We have included 'I don't mind' and 'no response' within this figure. A full list of comments can be found in **Appendix B**.

4.2.2 Other suggested play equipment

There were 80 "other" suggestions for the play area question. Key themes identified are presented in the table below. A full list of comments including 'other' comments can be found **in Appendix B**.

4.3. Nature Area


4.3.1 Opinion on the nature area

The majority of respondents approved of the proposals for the nature area.

When asked if they liked the idea of a bigger nature area, 69% of respondents agreed (*strongly agree/tend to agree*). 65% of respondents agreed (*strongly agree/tend to agree*) that they liked the plans to increase biodiversity in the park.

About two thirds (59%) of the respondents agreed (*strongly agree/tend to agree*) they liked the idea of a large pond.

A minority of respondents did not like the idea of a bigger nature area or plans to increase biodiversity in the park (10%) although a higher proportion of respondents disagreed (*strongly disagree/tend to disagree*) with the idea (17%) of having a large pond in the park.



4.4. Outdoor Gym


4.4.1 Types of gym equipment

Survey results reveal that the cross trainer (27%) was the most popular equipment among respondents, followed by spinning bike (26%), leg press/bench (25%) and hand bike (25%).

On the whole, differences in respondent rates between the options, particularly among the most popular were marginal.

Recumbent bike (19%), Dips/legs raise (19%) and Lat pull down/shoulder press (18%) had the lowest number of responses.

This point is reinforced by the fact that a notable proportion of respondents do not mind what equipment is installed in the gym area. In fact, at 39%, this was the highest rate of any question where 'I don't mind...' was chosen. Together with number of respondents who did not respond at all (14%), just over half of respondents completing the survey did not feel strongly enough about this area to offer a view.



4.4.1 Other suggested gym equipment

Respondents wishing to express interest in alternative gym equipment were allowed the opportunity to make a suggestion. A full list of comments including 'other' suggestions can be found in **Appendix B**.

There were 36 suggestions.

4.5. Further Comments

4.5.1 Analysis of responses

Near the end of the survey, respondents were asked for any other comments they may have regarding the proposals. This free text box was not restricted to any particular concern and so some of the comments flagged up by respondents repeated some of the issues raised in other parts of the survey.

For the purposes of analysis, comments were grouped into themes. The number of respondents for each theme may not correspond with the total number of comments received for each response because some respondents mentioned more than one theme in their comment.



4.6. Survey Demographics


4.6.1 Gender

5. Additional Feedback

5.1. Email and written correspondence

As part of the second phase of the consultation, residents were encouraged to send their thoughts about the updated plans via email or written correspondence. Nine emails were received with feedback about the plans. Three of these emails were from local community groups - SE5 Forum, Southwark Cyclists and Friends of Burgess Park. The full emails are detailed in **Appendix C**.

The key points raised in these emails relate to the following issues:

- Concern over the cycle pathways
- · Concern over safety of pedestrian crossing on New Church Road, outside project site
- Request for cyclist/pedestrian shared space at entrance to Addington Square, with a wider pathway for safety
- Concern about anti-social behaviour
- Concern that seats in Rust Square will encourage antisocial behaviour
- Concern over safety on cycle routes
- Request to move play area further from residential properties
- Retaining the GLC gates
- Request to retain GLC pillars
- Issues for consideration in final development plans
- Concerns over the consultation process
- Concern that cycle routes are not sufficient for future increase in cycling, request for segregated cycle
 paths and dropped kerbs to facilitate cycling

As an aside my daughter has also learnt to ride a bike in the park and I am not against cycling for recreational use within the park. There is a real opportunity being missed here to create an excellent park with excellent cycling infrastructure around it which could become a blueprint for the rest of London. Appendix C – Emails from stakeholders and residents

Dear XXX,

I wish to raise some access issues which I feel should be addressed within the Burgess Park Southern Entrance consultation. I've included an image which highlights the areas in question which hopefully this will be included in this email, if not, please let me know and I can send it again as a pdf.

On the south side of the park on New Church Road, adjacent to Edmund Street, there is a pedestrian crossing (zebra crossing) which I use when walking from Edmund Street into the park. This crossing is quite poorly designed as it is split into two parts for the east and west traffic. The route is a rat run for traffic trying to avoid the junction on Camberwell green and subsequently very few drivers will voluntarily stop at the crossing. Furthermore, if you are on the crossing, even at the halfway mark, drivers do not stop when travelling eastbound. It is my opinion that due to the split in the middle of the road, drivers perceive this to be two crossings or due to the barrier, they don't see pedestrians coming from the south side of the road. I often walk this route during week days around rush hour 17:30 – 17:45 and the conditions are particularly bad. On almost every occasion a car has driven right across my path when I am stepping out onto the north side of this crossing.

My suggestion is that the central divider on this crossing should be removed and opened up so that the crossing appears as a single entity making it much easier for drivers to be able to see the pedestrians. If that doesn't work, I would suggest that a pelican crossing be installed so that there is a clear mandatory stop sign for drivers.

Secondly, the proposal to create a shared surface for pedestrians and bicycles on the Addington Square entrance I think is necessary, if not essential, provided that adequate space is provided. The current problem here is that there is a narrow path only suitable for 2 pedestrians to pass and on the area highlighted a very narrow gate. A lot of cyclists use this path and come whizzing through, usually forcing the pedestrians to step out of the way, there is not enough room to pass. Coupled with the lack of space, the proposed cycle way also crosses New Church Road onto Edmund Street and this again is likely to be a danger hotspot if the cyclists attempt to ride across New Church Road during busy periods.

I've reviewed the consultation documents and none of them appears to address these issues as they are very high level concept drawings with little detail. However, I believe at this early stage these issues should be considered and included on the proposed changes.

If necessary I would be very happy to meet with you at the crossing to discuss this issue, I feel it is very important and should be addressed as part of the park improvements.

GLC Pillars at the Rust Square Entrance to Burgess Park

I hope this finds you well. I have, as a local resident, completed the online survey re the Burgess Park Southern Entrance Project and wanted to expand those comments with my SE5 Forum Chair hat on.

By 2011 it was becoming increasingly evident that a clearly marked, safe, pleasant way from Camberwell Green to Burgess Park would enhance the health and well being of visitors accessing the park. Cleaner, Greener, Safer funding for a feasibility study for the Lomond Grove Green Link was secured in 2012 and the project was completed with Southwark and TfL working together. We did not 'launch' the green link then as consultation on the site for the new Camberwell library was underway and that took precedence. Now access to the park will be further enhanced with the southern entrance project and I will follow progress with interest. My concern is that there does not appear to be any reference to the future of the iconic and historic GLC pillars marking the entrance from Rust Square. When SE5 Forum initiated the Lomond Grove Green Link the GLC pillars were viewed as one of the hidden treasures of Burgess Park rarely seen by park users and which could enhance their park experience. Surely these should be protected and respected as part of the unique history of a park created through several eras - politically as well as socially. Part of the considerable historic significance of the park is that Camberwell people were at the centre of its history – as residents, business owners, workers and commuters who were to be displaced by clearances but who could look forward to having an ambitious leisure resource created through what for many must have been a trying experience. The GLC pillars provide a strong signpost and visual marker to underpin this unique history and it is my hope that there is a future for the pillars in the new scheme. I have attached a photo of the pillars at the beginning of the Green Link initiative as well as plans of the green link. I hope this is helpful.

List of items from FOBP for consideration in the final development of the design for the southern entrance:

- 1. Location of the playground move further away from the houses possibly up as far as NCRd
- 2. BBQs move away from the houses possibly outside of current design area
- 3. Reduce paths immediately around the pond to ensure wildlife can nest possibly a bridge (like Dulwich Park)
- 4. More details on the cycle Quietway design and lighting
- 5. Retain trees / More details on number of trees coming down / Minimise tree loss
- 6. Turning circle needed for cars when Depot Street comes out.
- 7. Entrance way to be secondary (not like the main metal entrance)
- 8. Improving the grass in the main area
- 9. Retain at least one of the GLC brick pillars and globes and consider possible re-location of the second globe. There is no reference anywhere else (we think) of the GLC elsewhere in the park so will be and become of more historical significance
- 10. Consideration of the east /west route and the linkage to Camberwell (rather than Walworth/Camberwell Road) especially in relation to proposed cycle routes a lot of cyclists use NCRd
- 11. Flowers ongoing call for interesting and colourful planting at the entrance way
- 12. Opportunity to engage with local schools as part of the development process especially in the wildlife and environmental aspect of the new design, build in opportunities
- 13. Consideration of natural play (on-going request from FOBP) and play opportunities across the park

Overall position

Southwark Cyclists welcomes the further investment in the Park, including the removal of New Church Road within the Park and the additional natural features. We are concerned that the consultation process has been fundamentally flawed, however.

There has been very limited consideration of cycling here, partly as the spine route further east has diverted attention and partly as there is a Londonwide issue of inadequate consideration about future-proofing the public realm for increased levels of cycling. The proposed system of routes appears not to serve cycling well, damaging the aims of the Strategy as well as potentially creating conflict between users within the Park.

In particular we are concerned about the proposed removal of the cycle tracks on New Church Road. This is a proposed cycle route with relatively high volumes of motor traffic, meaning that separated space for cycling is essential.

Adequacy of the consultation

Unfortunately it is not possible for consultees to provide intelligent comment to this consultation as the materials provided fail to deal adequately or at all with:

- the proposed new TfL quietway route, in relation to which consultation will commence shortly;
- forecast or intended increases in cycling in Southwark's Cycling Strategy ('the Strategy'), which will mean the Park and surrounding streets will need to cater for a significantly different mix of users (including a much wider demographic cycling than we see at present) during the lifetime of the improvements to what it does currently;
- wider plans for cycling in and around Burgess Park. For example the Strategy appears to suggest that existing East-West cycle routes (such as National Cycle Route 425: http://www.sustrans.org.uk/ncn/map/route/route-425) through the Park will not feature in the proposed network.

These are significant issues that have a real impact on the optimum layout of this part of the Park. In the circumstances, the consultation was not lawful and needs to be rerun with these issues addressed, if LB Southwark wishes to continue with these proposals.

Detailed matters

The Strategy shows proposed cycle routes will converge from five directions at the eastern end of New Church Road. One of these will be branded as a quietway. The interface between these route should be coherent but the plans do not show it to be. The quietway route between Edmund Street and Portland Street would be particularly convoluted and many users would be likely to take a short cut using where New Church Road is currently. This desire line should be considered for making the main cycle route through this section of the Park. In any event

Consideration should be given to separating the the main path for cycling and other users, as is common in the Netherlands in similar situations. A 5m wide path would be visually dominating - by creating a small gap between paths this impact would be reduced as well as making it more permeable for wildlife. The proposed 5m wide shared route is unlikely to will work well in five let alone ten years time as peak cycle flows continue to increase: it is better to separate out users on higher volume routes through parks.

It should be a condition of planning permission that the existing cycle track is not removed until alternative separated cycle paths are provided.

The interface for cycling between the Park itself and adjacent highways is very poor at present and it is critical that additional thought is given to this. There should be improved permeability between Kitson Road and Lomond Grove - this is a parallel, quiet alternative to Camberwell Road. There should be a better dropped kerb or level way between the north west corner of Addington Square and the Park.

In planning terms, the National Planning Policy Framework states that bad design can be a reason in itself to refuse planning permission, while the Planning Policy Guidance on Design highlights the importance of adaptability and consideration of future needs. The current proposals fail to comply with national policy.

Next steps

Southwark Cyclists would be pleased to discuss these matters further with LB Southwark as we are keen that the Park can be improved for its existing and future users as soon as possible.

We met a few weeks ago at the consultation over the Burgess Park Southern entrance redesign and I wanted to follow up on our conversation ahead of tomorrow's deadline to reiterate both my support for the overall plan – a really excellent design – and my concern around the location of the playground area in close vicinity of our properties.

As I explained on the day we already have significant antisocial behaviour behind our properties with street drinkers using the existing low wall throughout the year. In Summer it is often also a focal point for rowdy all-night parties. Removing that wall as you plan to do is therefore very welcome.

However, replacing it with a new playground runs counter to that despite your careful design. Even when used properly it will entail us having to endure significant noise and other undesirable side-effects for which there is no need given the size of the park.

One suggestion you were open to explore would be to move the playground closer to the nature reserve and use it as an opportunity to get children to learn about nature while playing; it would result in a better design that serves all users including residents who live next to the park. I am happy to discuss further if that is of assistance. In the meantime, I would be grateful for your response to moving the playground away from our properties.

Dear XXX,

Unfortunately I have been away and unable to attend any of the consultation events regarding the development of this corner of the park. I realise that the consultation period has just elapsed but I hope that my opinion can be taken into account as I am directly affected by the playground proposal which would be directly behind my house.

As you will be aware we have suffered greatly from antisocial behaviour behind our houses on the south side of the square and the removal of the steps would be a great improvement. While the overall plan is excellent and the creation of a new lake will be a great enhancement to this part of the park I am very concerned about the siting of the new playground just behind our homes and the attendant noise and other side effects it would bring. Given the size of the park it seems unecessary to site the playground so near to houses and tucked away in this corner of the park..

I understand that you might consider siting the playground near to the new lake which would enable nature studies as well as play. It would also make the playground nearer to the facilities of the tennis pavilion and be more convenient for families with children who want to play while siblings are having tennis lessons. Siting the playground a little further into the body of the park would

be to the benefit of all its users.

We are very pleased with the over all plans, particularly the opening up of Rust Square, making it part of the park, and the plans for the large pond.

The idea that has caused most concern however is that the children's play area is planned adjacent to the back gardens of the houses on the south side. Indeed every householder there has made their feelings against this known to me.

The only other concern was that the barbeque area seemed a bit close to the houses on the east side.

Everyone is enthusiastic about more gym equipment but there is a strong preference for having them spaced out and not clumped together. This makes them less intimidating to use and more available for everyone.

I trust these views can be included in the consultation which ofcourse ends tonight.
