DENMAN ROAD	I do not want to pay for parking nor do I want visitors to have to pay. We pay enough tax as it is.
SHENLEY ROAD	I think having parking restrictions in the middle of the day is a good option, so visitors and workmen can visit in the morning or afternoon without incurring a charge.
	But I do think the permit fees should be kept as low as possible, as otherwise it is yet another expense on already strained budgets.
BUSHEY HILL ROAD	It's about time this happened so our street isn't used as a high speed rat run so frequently, and as a car park by non-residents!
	We can never park our one car and our visitors or delivery drivers are always frustrated that they can't park.
CROFTON ROAD	Very pleased that you are revisiting this issue. The parking problem we now have in Crofton Road is severe and is caused by commuters who use our street as a free parking lot. This was not an issue in 2012 when the previous consultation occurred.
