Long Lane and Wild's Rents junction - installation of controlled pedestrian crossing and prohibition of motor vehicle restriction

The London Borough of Southwark (Charged-for parking places) (Wild's Rents area) Order 202* The London Borough of Southwark (Waiting restrictions) (Wild's Rents area) Order 202* The London Borough of Southwark (Prescribed routes) (Wild's Rents area) Traffic Order 202*

- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. as amended.
- 2. The effects of the (Charged-for parking places) Order would be within Controlled Parking Zone 'D' in WILD'S RENTS south-east side opposite its junction with Elim Street remove 9 metres of existing 'shared-use' (CPZ 'D' permit-holders and pay by phone parking only) parking.
- 3. The effects of the (Prescribed routes) Traffic Order would be to make amendments to certain prescribed route restrictions in the Wild's Rents area as described below:-
- (a) to remove an existing 'one-way' south-westward operation in WILD'S RENTS (and associated no entry except cycles and 'left only' turn in Decima Street);
- (b) to introduce a new 'no motor vehicles' restriction in WILD'S RENTS, where there will no access for motor vehicles between a point 4 metres south-west of the south-western kerb-line of Long Lane and a point 18 metres south-west of that kerb-line, the full length of which will be a designated shared pedestrian and cycle zone for use of pedestrians and cycles only; and
- (c) to prohibit vehicles (except cycles) turning into WILD'S RENTS from LONG LANE.

 All new restrictions mentioned above would be operational 'at any time' and all days of the week.

 Exemptions would not be provided for any vehicles (including emergency services vehicles) for the safety of the users of the shared pedestrian and cycle zone. All new restrictions mentioned above would be operational 'at any time' and all days of the week. The road closure and shared pedestrian and cycle zone will be enforced by signs and fixed bollards.
- 4. The effects of the (Waiting and loading restrictions) Order, would be:-
- (a) in ELIM STREET north-west of its junction with Wild's Rents (i) south-west side convert 2.5 metres of timed waiting restrictions (single yellow lines 'SYLs', which were operating Monday-Friday between 8:30 am and 6:30 pm) into 'at any time' waiting restrictions (double yellow lines 'DYLs') and (ii) formalise 14 metres existing 'DYLs' on the north-east side, and 13 metres existing 'DYLs' on the south-west side;
- (b) in LONG LANE (i) on both sides remove redundant waiting restrictions (both timed and 'at any time) to accommodate the new zebra pedestrian crossing, and o/s No. 228 Long Lane convert 6 metres of existing SYLs to DYLs (12 metres in total), and (ii) north-east side add 18 metres new 'SYLs' o/s Nos. 201 to 211 Long Lane operating Monday-Friday between 8:30 am and 6:30 pm; and
- (c) in WILD'S RENTS (i) south-east side opposite its junction with Elim Street add 9 metres of new 'SYLs' operating Monday-Friday between 8:30 am and 6:30 pm, to accommodate the removal of parking, and (ii) remove existing 'DYLs' on both sides between its junction with Long Lane and a point 18 metres south-west of that junction, and add 4 metres of new 'DYLs' on the north-eastern side to accommodate the new shared pedestrian and cycle zone.

NOTES: All measurements are in metres and are approximate. Parking charges are listed on www.southwark.gov.uk/parking

5. Southwark Council hereby GIVES FURTHER NOTICE that it has approved under section 23 of the Road Traffic Regulation Act 1984, the provision of a raised 'zebra' pedestrian crossing in LONG LANE the centre of which would be located at a point 3 metres north-west of the common boundary of Nos. 218 and 220 Long Lane. 'Zig-zag' markings, on which vehicles would be prohibited from stopping at all times, would be laid on the main carriageway:- (a) for a distance of 20 metres north-westward of the crossing and (b) for a distance of 16 metres south-eastward of the crossing).

- 6. Southwark Council hereby GIVES FURTHER NOTICE under sections 90A to 90I of the Highways Act 1980 and in accordance with the provisions of the Highways (Traffic calming) Regulations 1999, propose to construct a speed tables of flat-top construction having a maximum height level with the surrounding kerb covering the entire width of the carriageway at the site of the 'zebra' pedestrian crossing described in item 5 above, in LONG LANE extending from a point 2 metres south-east of the common boundary of Nos. 218 and 220 Long Lane north-westward for a distance of 15 metres, and extending into WILD'S RENTS from its junction with Long Lane south-westward for a distance of 18 metres.
 - The measurements above include the ramps and any existing traffic calming measures at the exact locations above will be refreshed and replaced.

Statement of reasons

Long Lane and Wild's Rents junction - installation of controlled pedestrian crossing and prohibition of motor vehicle restriction

The London Borough of Southwark (Charged-for parking places) (Wild's Rents area) Order 202* The London Borough of Southwark (Waiting restrictions) (Wild's Rents area) Order 202* The London Borough of Southwark (Prescribed routes) (Wild's Rents area) Traffic Order 202*

The scheme proposes changes in Elim Street, Long Lane, and Wild's Rents (within the Chaucer ward and London Bridge & West Bermondsey ward), in the London Borough of Southwark.

The overall purpose of the project is to implement traffic calming in the form of a new raised zebra pedestrian crossing in Long Lane at its junction with Wild's Rents to improve accessibility for pedestrians and reduce the speed of traffic. The scheme will make changes to existing prescribed route in Wild's Rents to create a designated shared pedestrian and cycle zone to make the area better adapted to sustainable modes of transport and to improve air quality. The scheme will include resurfacing and paving to further compliment the traffic calming and improved access for pedestrians, as well as the necessary changes to the highway as detailed below.

In summary, the proposed changes to the highway are:

- (1) in Wild's Rents, remove an existing 'one-way' south-westward operation (and associated no entry except cycles and 'left only' turn in Decima Street), and install a new 'no motor vehicles' restriction south-west of its junction with Long Lane to prohibit motor vehicles from this section of Wild's Rents, and to prohibit vehicles (except cycles) turning into Wild's Rents from Long Lane. This section of Wild's Rents will be designated as a shared pedestrian and cycle zone for use of pedestrians and cycles only. The road closure and shared pedestrian and cycle zone will be enforced by signs and fixed bollards and there will be no access for emergency vehicles, for the safety of the users of the shared pedestrian and cycle zone;
- (2) in Wild's Rents, remove 9 metres of existing 'shared-use' (CPZ 'D' permit-holders and pay by phone parking only) parking 'shared-use' parking on the south-east side opposite its junction with Elim Street within Controlled Parking Zone 'D' to accommodate vehicle turning manoeuvres in the approach to the new road closure;
- (3) install a new raised zebra pedestrian crossing in Long Lane at its junction with Wild's Rents, the raised speed table will extend into Wild's Rents for the full length of the shared pedestrian and cycle zone. This will improve the visibility and slow vehicle speeds;
- (4) make changes to existing and add new waiting restrictions (single and double yellow lines) in Long Lane and Wild's Rents to accommodate the new raised zebra pedestrian crossing, the parking changes and the new shared pedestrian and cycle zone; and
- (5) formalise sections of existing 'at any time' waiting restrictions (double yellow lines) on both sides of Elim Street north-west of its junction with Wild's Rents that are marked in the location, this will be an administrative exercise only to match what is in the street to Southwark Council's map-based schedule.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the specific type of parking place amended by this Order and, where appropriate, certain of its governing provisions; and

Interpretation

2.1 In this Order:-

"this Order" means the London Borough of Southwark (Prescribed routes) (Wild's Rents area) Traffic Order 202*:

"Council" means the Council of the London Borough of Southwark;

"Wild's Rents shared pedestrian and cycle zone" means the entirety of the carriageway of the part of Wild's Rents which lies between a point 4 metres south-west of the south-western kerb-line of Long Lane and a point 18 metres south-west of that kerb-line, and which provides a separate two-way carriageway for the use of pedal cycles only;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"kerb-line" means the imaginary line which is the projection of the line formed by the edge of the carriageway of a street;

"motor vehicle" has the same meaning as in section 136 of the Road Traffic Regulation Act 1984;

"pedal cycle" has the same meaning as in Schedule 1 to the Traffic Signs Regulations and General Directions 2016^b; and

"traffic sign" means a sign of any size, type and colour prescribed and authorised under, or having effect as though prescribed or authorised under section 64 of the Road Traffic Regulation Act 1984.

2.2 Any reference in this Order to any enactment must be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Prescribed routes

- 3.1 No person shall cause any motor vehicle to enter into or proceed in that part of Wild's Rents which lies between a point 4 metres south-west of the south-western kerb-line of Long Lane and a point 18 metres south-west of that kerb-line, or the Wild's Rents shared pedestrian and cycle zone.
- 3.2 No person causing any vehicle to proceed in a north-westward direction in Long Lane, except for a pedal cycle, shall upon reaching its junction with Wild's Rents, cause that vehicle to turn left into Wild's Rents or Wild's Rents shared pedestrian and cycle zone.
- 3.3 No person causing any vehicle to proceed in a south-eastward direction in Long Lane, except for a pedal cycle, shall upon reaching its junction with Wild's Rents, cause that vehicle to turn right into Wild's Rents or Wild's Rents shared pedestrian and cycle zone.

Exemptions

- 4.1 Nothing in Articles 3.1 to 3.3 of this Order shall apply in relation to:-
 - (a) anything done with the permission or at the direction of a police constable in uniform; or
 - (b) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed on the highway pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.

Amendment of existing Orders

5.1 Without prejudice to anything done or any liability incurred in respect of any act or omission before the coming into force of this Order, the London Borough of Southwark (Prescribed Routes) (No. 2) Traffic Order 1990° will have the effect as though item 3 in Schedule 1 therein is omitted, and the London Borough of Southwark (Prescribed routes) (Pedal cycle permeability) (No. 1) Traffic Order 2012d will have effect as though Articles 12.1, 12.2 and 12.3 therein are omitted.

This Order consolidates and make amendments to certain prescribed route restrictions within the Wild's Rents area, on a permanent basis in the London Borough of Southwark, to remove an existing 'one-way' south-westward operation in Wild's Rents (and associated no entry except cycles and 'left only' turn in Decima Street) and install a new 'no motor vehicles' restriction south-west of its junction with Long Lane to prohibit motor vehicles from this section of Wild's Rents, and to prohibit vehicles (except cycles) turning into Wild's Rents from Long Lane. This section of Wild's Rents will be designated as a 'shared pedestrian and cycle zone' for use of pedestrians and cycles only. The road closure and shared pedestrian and cycle zone will be enforced by signs and fixed bollards and there will be no access for emergency vehicles, for the safety of the users of the shared pedestrian and cycle zone.
