North Cross Road Market

The London Borough of Southwark (prohibition of Vehicles and Waiting Restrictions) (North Cross Road Market) Traffic Order 2017.

- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above order under the powers of the Road Traffic Regulation Act 1984.
- 2. The effect of the orders would be:-
 - (a) To prohibit vehicles driving through North Cross Road between its junctions with Lordship Lane and Archdale Road, effective between 8am and 5pm on Saturdays when the street market occurs.
 - (b) To introduce single yellow line waiting restrictions in North Cross Road between its junctions with Lordship Lane and Archdale Road, effective between 8am and 5pm on Saturdays when the street market occurs.
 - (c) To introduce single yellow line waiting restrictions in Nutfield Road at its junction with North Cross Road to provide a turning area for vehicles when North Cross is closed, effective between 8am and 5pm on Saturdays when the street market occurs.
 - (d) To amend the free parking spaces and solo motorcycle parking spaces in North Cross Road so they are not available between 8am to 5pm on Saturdays, when the street market occurs
 - (e) To remove a prohibition of waiting between 7am and 4pm on Fridays on the south side of North Cross Road between its junction with Nutfield Road and a point 3.5m south east of the eastern wall of No.55 North Cross road, so people may park there on Fridays.
