Engines to be turned off when stationary in parking places, free parking places, loading bays and on waiting restrictions

The London Borough of Southwark (Engines to be turned off when stationary) (Parking places, free parking places, loading bays and waiting restrictions) (No. 1) Order 2017

- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above order under sections 6, 45, 46, 49 and 128 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹, as amended, and of all other powers thereunto enabling.
- 2. The effect of the order would be to prohibit vehicles from waiting with the engine running, regardless of whether the vehicle is attended, in all pay parking places, free parking places, loading bays and on all waiting restrictions throughout the borough so as to reduce environmental pollution caused by vehicles.

Statement of reasons

Engines to be turned off when stationary in parking places, free parking places, loading bays and on waiting restrictions

The London Borough of Southwark (Engines to be turned off when stationary) (Parking places, free parking places, loading bays and waiting restrictions) (No. 1) Order 2017

- This purpose of this scheme would be to prohibit vehicles from waiting with the engine running, regardless of whether the vehicle is attended, in all pay parking places, free parking places, loading bays and on all waiting restrictions on streets throughout the borough - and thereby reduce the environmental pollution caused by idling vehicles.
- If made, the order would be enforced on-street by the Council's Civil enforcement officers, using contravention code 63.

The council of the London Borough of Southwark, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984^a, and of all other powers thereunto enabling, hereby make the following Order:-

Citation and commencement

1.1 This Order may be cited as the London Borough of Southwark (Engines to be turned off whilst vehicles are stationary) (Parking places, free parking places, loading bays and waiting restrictions) (No. 1) 2017 and shall come into force on 2017.

Interpretation

2.1 In this Order:-

"council" means the council of the London Borough of Southwark;

- "enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and
- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2012 shall have the same meaning as in that Order.
