Bath Terrace and Harper Road introduction of permanent width restrictions

The London Borough of Southwark (Width restriction) (Bath Terrace and Harper Road) (No. *) Traffic Order 201*, The London Borough of Southwark (Prescribed routes) (Harper Road) (No. *) Traffic Order 201*, The London Borough of Southwark (Waiting and loading restrictions) (Amendment No. *) Order 201*

- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above orders under the powers of the Road Traffic Regulation Act 1984¹, as amended.
- 2. The effect of the orders would be:-
- (a) in BATH TERRACE, (i) on both sides throughout the road, to convert single yellow lines to double yellow line 'at any time' waiting restrictions; (ii) at its north-eastern end on the south-east side, to formalise an existing width restriction previously trialled under the Experimental Order: The London Borough of Southwark (Width restriction) (Harper Road and Bath Terrace) (No. 1) Experimental Traffic Order 2018², outside Nos. 1 to 28 Bath Terrace in which vehicles of more than 2 metres (6 feet 6 inches) in overall width, including any load carried thereon, would not be permitted to enter or proceed. This restriction will be physically enforced by the permanent structures which are currently in this location;
- (b) in BROCKHAM STREET the south-east side, to convert a length of existing single yellow line to double yellow line 'at any time' waiting restrictions (14 metres) at its junction with Harper Road; and
- (c) in HARPER ROAD, between its junction with Brockham Street/Bath Terrace and its junction with Dickens Square:- (i) an existing width restriction which was trialled under the aforementioned Experimental Order, currently across both north-east and south-west sides of Harper Road, will be removed in its entirety; (ii) a new width restriction will be introduced on the north-east side only of Harper Road (south-eastbound lane), in which vehicles of more than 2 metres (6 feet 6 inches) in overall width (including any load carried thereon) would not be permitted to enter or proceed. This restriction will be physically enforced by permanent build-out structures in the north-east side of Harper Road, outside the Baitul Aziz Islamic Cultural Centre, No. 1 Dickens Square; (iii) to prohibit any vehicle travelling in a south-easterly direction from entering or proceeding in the part of Harper Road which lies, on the south-west side, immediately adjacent to the abovementioned width restriction. This restriction will cover the entire length as described above and the entire width of carriageway as measured from the centre of Harper Road to its south-western kerb-line and will be enforceable by traffic cameras; and (iv) to convert existing single yellow lines to double yellow line 'at any time' waiting restrictions in this section of Harper Road.

Statement of reasons

Bath Terrace and Harper Road introduction of permanent width restrictions

The London Borough of Southwark (Width restriction) (Bath Terrace and Harper Road) (No. *) Traffic Order 201*

The London Borough of Southwark (Prescribed routes) (Harper Road) (No. *) Traffic Order 201* The London Borough of Southwark (Waiting and loading restrictions) (Amendment No. *) Order 201*

Council Officers have monitored traffic since the introduction of width restriction measures in Harper Road and Bath Terrace, in the Chaucer ward of the London Borough of Southwark. The width restriction measures were trialled under an experimental traffic order (our reference TMO17/18-EXP03_Harper Road) dated 18 January 2018, and implemented in March 2018. Council Officers have engaged with residents and members of the public as well as emergency services. The traffic monitoring has found a reduction in vehicles using the road and particularly large vehicles (or Heavy Goods Vehicles). Informal consultation revealed majority support for retaining the width restrictions on a permanent basis, although concerns were raised about access for large emergency vehicles. Emergency services requested access for all emergency vehicles including ambulances, preferably with traffic camera enforcement to prevent any delays in response time that could be caused by lockable gates or bollards.

The width restriction of 2 metres (6 feet 6 inches) in the north-eastern end of Bath Terrace outside Nos. 1 to 28 Bath Terrace will be retained on a permanent basis without modifications.

The width restriction under the experimental traffic order in Harper Road, which operates as a 2 metre wide alternate one-way lane reinforced with traffic islands, will be removed in its entirety as it is not accessible to all emergency vehicles.


A new permanent width restriction in Harper Road (outside the Baitul Aziz Islamic Cultural Centre, No. 1 Dickens Square) is proposed with an eastbound 2 metre wide traffic lane, reinforced with a central island and robust bollards. The westbound lane, directly adjacent to the location of the new width restriction, will be 3.2 metres (10 feet 6 inches) wide and there will be a 'no entry' point prohibiting all eastbound vehicles, except for emergency vehicles, from proceeding against the flow of traffic in this lane, for example to overtake another vehicle or to avoid the width restriction. The 'no entry' will be enforceable by traffic cameras.



2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Width restriction

BATH TERRACE

3.1 No person shall cause any vehicle of more than 2 metres (6 feet 6 inches) in overall width (including any load carried thereon) to enter into or proceed in Bath Terrace in that length which lies between a point 53 metres south-east of the south-eastern kerb-line of Harper Road and a point 55 metres south-east of that kerb-line, as measured from the south-east side of Bath Terrace.

HARPER ROAD

3.2 No person shall cause any vehicle of more than 2 metres (6 feet 6 inches) in overall width (including any load carried thereon) to enter into or proceed on the north-east side of Harper Road (south-eastbound lane) in that length which lies between a point 26 metres south-east of the south-eastern kerb-line of Brockham Street and a point 16 metres north-west of the north-western kerb-line of Dickens Square, as measured from the north-east side of Harper Road.

Exemptions

- 4.1 Nothing in Article 3.1 above shall apply in relation to:-
 - (a) anything done with the permission or at the direction of a police constable in uniform;
 - (b) any vehicle being used for ambulance, fire brigade or police purposes in an emergency;
 - (c) any vehicle being used in connection with the laying, erection, alteration, or repair in or adjacent to the prescribed street of any sewer, main, pipe or apparatus for the supply of gas, water, electricity, or of any communications network (within the meaning of the Communications Act 2003^b); or the placing, maintenance or removal of any traffic sign, if the vehicle cannot be used for that purpose in any other street; or
 - (d) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed on the highway pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.

1.1 This Order may be cited as the London Borough of Southwark (Prescribed routes) (Harper Road) Traffic Order 201* and shall come into force on xx xxxxxxx 2019.

Interpretation

2.1 In this Order:-

causing includes permitting;

"designated carriageway width" for the purposes of Article 3 means the section of carriageway in Harper Road that is bounded on one side of that length by its south-western kerb-line and having a width throughout of 3.2 metres;

"enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"prescribed routes", for the purposes of Article 4 means the length of street referred to in Article 3 of this Order, which lies in the London Borough of Southwark;

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Prescribed routes

3.1 No person shall cause any vehicle to proceed in a south-easterly direction in the section of Harper Road, which includes the full designated carriageway width, that lies between a point 26 metres south-east of the south-eastern kerb-line build-out of Bath Terrace and a point 27.5 metres north-west of the north-western kerb-line build-out of Rockingham Street.

Exemptions

- 4.1 Nothing in Article 3 above shall apply in relation to:-
 - (a) anything done with the permission or at the direction of a police constable in uniform;
 - (b) any vehicle being used for ambulance, fire brigade or police purposes in an emergency;
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed on the highway pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984; or
 - (d) any vehicle being used in connection with the laying, erection, alteration, or repair in or adjacent to a prescribed street of any sewer, main, pipe or apparatus for the supply of gas, water, electricity, or of any electronic communications network; or the placing, maintenance or removal of any traffic sign, if the vehicle cannot be used for that purpose in any other street or part of that street.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits all vehicles from entering or proceeding in a south-easterly direction in the part of Harper Road, on the south-west side (north-westbound lane) only between its junctions with Bath Terrace and Rockingham Street, to work with the introduction of a width restriction in the north-east side (south-eastbound lane) of Harper Road, in the London Borough of Southwark.
